The ESS peer review process and follow-up

The ESS peer review process follows these main steps:



- Completing self-assessment questionnaires (SAQs) by the national statistical authorities.
- Analysing these SAQs and other documents and information by the expert team.
- An in-depth country visit by the expert team;
- Drafting the final report and ensuing recommendations by the expert team.
- Drafting concrete improvement actions by the national statistical institute to address the recommendations.
- Monitoring of the improvement actions on an annual basis by Eurostat.

Completing the SAQs



- The SAQ addresses all 16 Principles of the European Statistics Code of Practice.
- The national statistical authorities must indicate how they are complying with the Code and provide documented evidence.
- In addition questions have to be answered on forward-looking/innovative practices.
- SWOT (Strengths, Weaknesses, Opportunities, Threats) analysis for each Principle.

Analysis of the SAQs



- The expert team analyses the SAQs and the accompanying documentation.
- A combination of an audit-like approach and a peer review approach is used by the expert team.
- Any gaps or inconsistencies in the information provided are flagged and form the basis for the follow-up questions to be asked during the peer review visit.

The country visit

- The country visit lasts 4-5 days and follows an agenda agreed beforehand between the expert team and the national statistical institute.
- Participants include members of staff of the national statistical authorities, representatives of users, researchers, data providers, media...
- Not all Principles must be covered the expert team is able to decide which Principles to assess following the analysis of the SAQ (possible problematic areas or issues which need further clarification).
- BUT mandatory assessment of Principles dealing with professional independence, coordination and cooperation within the national statistical system, and modernisation.

The final report and recommendations

- The final report and the ensuing recommendations are drafted by the expert team based on its findings.
- The expert team has sole ownership of the report and the recommendations.
- The final report identifies:
- Strengths including forward-looking practices.
- Areas for improvement through recommendations for follow-up by the national statistical authorities.

Drafting improvement actions by the national statistical institute



- The national statistical institute, in cooperation with the reviewed other statistical authorities drafts improvement actions to address the recommendations.
- The improvement actions are based on the SMART approach (Specific, Measurable, Attainable, Relevant, and Time-bound).

Monitoring of the improvement actions



- The implementation of the improvement actions by the national statistical authorities is monitored by Eurostat on an annual basis.
- An annual monitoring report is then submitted by Eurostat to the <u>European Statistical System</u> <u>Committee</u> – the oversight body of the ESS.
- The monitoring of this round of ESS peer reviews will end in December 2027.
