# 0. Basic information

• Purpose, goal, and subject of the survey

Data collected by the basic survey relate to areas of vineyards, vine varieties and age classes of vineyards. Data on the area of vineyards were taken over from the Paying Agency for Agriculture, Fisheries and Rural Development.

Basic surveys on the structure of vineyards are conducted every five years. They have been conducted since 1979 and are compulsory for all Member States that have 500 or more hectares of vineyards, provided that the production is mainly intended for the market.

The data are extracted from the Vineyard Register. Data on the areas of vineyards refer to the situation as on 31 July 2015. Survey results are available in the NKPJS – 1st level and in the NKPJS – 2nd level.

Management rules for the collection of data on vineyards are defined by the Regulation (EU) No 1337/2011. Data on the area of vineyards were taken over from the Paying Agency for Agriculture, Fisheries and Rural Development in accordance with the Ordinance on Registration of the Agricultural Land Use (OG, No. 149/11), the Ordinance on the Vineyard Register, Compulsory Declarations, Accompanying Documents, Cellar Records and Production Potential (OG, Nos 48/14, 83/14 and 147/14) and the Ordinance on the National List of Recognised Vine Varieties (OG, No. 53/14).

Concepts and definitions

Vines intended for purposes other than the production of table grapes. The survey on vineyards includes vines intended for purposes in addition to the production of table grapes. Vine intended for the production of table grapes is covered by the survey on orchards. Vine for other purposes refers to all areas under vines included in the Vineyard Register under Article 3 of the Commission Regulation (EC) No 436/2009 of 26 May 2009 laying down detailed rules for the application of Council Regulation (EC) No 479/2008 as regards the vineyard register, compulsory declarations and the gathering of information to monitor the wine market, the documents accompanying consignments of wine products and the wine sector registers to be kept. Vine for purposes other than the production of table grapes is used for the production of wine, dried grapes and vegetative propagation of vines. Areas under vines include areas in production, areas not yet in production and areas intended to produce material for vegetative propagation of vines.

Statistical units

The statistical unit is a wine-grower holding growing vines intended for other purposes than the production of table grapes on the area of more than 0.1 hectares, which is registered in the Vineyard register.

# • Statistical population

The statistical population is a wine-grower holding with vines intended for other purposes than the production of table grapes on the area of more than 0.1 hectares, which is registered in the Vineyard register. Vines grown in EU Member States with the total area under vines of less than 500 hectares are excluded from data collection.
