Married persons are those who got married before a competent body in concordance with valid regulations.

Widowed persons are persons whose marriage ceased to exist by death of one of spouses or by declaring a missing spouse dead respectfully.

Divorced persons are those whose marriage was terminated by a valid court decision.

Marriage is an act by which the legal relationship of husband and wife is constituted. Divorce is the final dissolution of a marriage by a valid decision of a competent court. Marriage annulment is the final dissolution of a marriage constituted against regulations for a legitimate marriage by a valid decision of a competent court.
