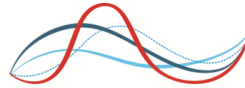

## 0 Basic information

- Purpose, goal, and subject of the survey

In order to calculate the volume index of agricultural production, data on the quantities of agricultural products produced are taken over from the following regular surveys on crop and livestock production statistics:

- The Report on Yields of Early Crops and Fruits
- The Report on Yields of Late Crops, Fruits and Vineyards
- The Report on Yields of Citrus Fruits and Olives
- The Annual Report on Livestock Production on Agricultural Holdings (Business Entities and Family Farms)
- The Monthly Report on Livestock and Poultry Slaughtering in Abattoirs
- The Monthly Report on Livestock and Poultry Slaughtering – Tradesmen
- Data on import and export of live animals.

Data on average prices of agricultural products, in the first market stage of sales, are taken over from the following agricultural price statistics surveys:

- The Monthly Report on Sale of Agricultural, Forestry and Fishing Products from Own Production – Legal Entities and Tradesmen
- The Monthly Report on Purchase of Agricultural, Forestry and Fishing Products – Private Family Farms.

Volume indices of agricultural production are calculated on the basis of production data of 65 agricultural products. This survey provides the chain indices of gross agricultural production – crop and livestock production and the chain index of net agricultural production.

The data obtained are in line with EU standards.

- **Statistical units**

For agricultural price statistics, statistical units are covered by section A Agriculture, forestry and fishing – division 1, except group 01.7 Hunting, trapping and related service activities, according to the NKD 2007., taken over from the Statistical Business Register (SPR) for units employing 10 and more persons and from the Tax Administration Register for craftsmen employing 5 or more persons.

Business entities engaged in crop production statistics were taken over from the Registry of Agricultural Holdings of the Paying Agency for Agriculture, Fisheries and Rural Development and from the Statistical Business Register (SPR).

Agricultural holdings cover all agricultural holdings with at least 40 acres of utilised agricultural area or:

- less than 40 acres of utilised agricultural area, but having:
- 10 acres of orchards/vineyards/olive groves
- any area of vegetables, flowers and ornamental plants intended for market

The coverage of business entities included in the livestock production survey is selective (10 or more employees), while reporting units were taken over from the Statistical Business Register and the Statistical Register of Agricultural Holdings. Statistical units are also family farms engaged in livestock and poultry farming, which were selected on the sample basis.

- **Statistical population**

Legal entities and parts thereof defined in section A Agriculture, forestry and fishing – division 1, except group 01.7 Hunting trapping and related service activities, according to the NKD 2007., in the Statistical Business Register (SPR), in the Statistical Register of Agricultural Holdings and in the Registry of Agricultural Holdings of the Paying Agency for Agriculture, Fisheries and Rural Development as well as tradesmen taken over from the register of Tax Administration engaged in agricultural activities, and family farms.
