The Register of Business Entities includes legal entities, state government bodies, bodies of local and regional self-government units and parts thereof. When entering in the Register of Business Entities, the Croatian Bureau of Statistics issues to business entities and parts thereof the Notification on the Classification of Business Entities According to the NKD 2007.
