(NN, Nos 58/07 and 72/07) and the Ordinance on the Classification of Business Entities According to the National Classification of Activities, 2007 version – NKD 2007. (NN, No. 55/16 and 35/18). The Croatian Bureau of Statistics classifies business entities and parts thereof according to the NKD 2007.

The Register of Business Entities covers all legal entities, state government bodies, bodies of local and regional self-government units and parts thereof. When entering them into the Register of Business Entities, the Croatian Bureau of Statistics issues to business entities and parts thereof the Notification on the Classification of Business Entities according to the NKD 2007.
