• Purpose, goal, and subject of the survey

Data on libraries that operated in the Republic of Croatia in 2010 were collected in this survey. A total of 1 731 libraries operated in 2010. Out of that number, 8.4% of libraries were autonomous, 5.9% made part of another library and 85.7% made part of an institution/enterprise.

Library is an organisation or a part of an organisation with the main aim to build and maintain its collection and facilitate the use of information sources and equipment required to meet the informational, research, educational or recreational needs of its users. A total of 1 731 libraries operated in 2010. Out of that number, 8.4% of libraries were autonomous, 5.9% made part of another library and 85.7% made part of an institution/enterprise. The number of library members amounted to 1 393 581 (55.7% of women). The majority were school library members (39.0%), followed by public library members (37.5%) and library members at institutions of higher education (17.0%).
